Remember, Federal Laws States that if a line containing a explosive material and is it and leaking the Fire Dept. MUST be called.

Standards Report: Frank asked about calling in Emergency Locates then start digging without marks. Is that legal/acceptable? Tobin quoted from the Standards Manual. It basically said you can but only with non-invasive methods. Such as hand shovels, vacuum vactor. But when using a vactor you must use a pressure hose that has a O-tip with no more than 1,200 PSI or a Fan Tip with no more than 1,500 PSI. Please refer to the Standard's Manual for any clarification on this. Please do not take my notes here as Law Set in Stone!
