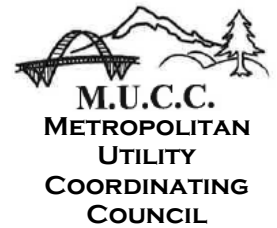

The OUNC Board is putting together a new committee for Damage Reporting. They will meet either July 25th or August 1st from 10 a.m. to 12 p.m. at Century Link at 1762 W 2nd Ave, Eugene OR. They are going to use a virtual DIRT reporting system. Currently, reporting damages is voluntary. At this first meeting, they will identify who will be the head administrator (who will grant permissions for use) and which fields are needed in reporting.
