The meeting was called to order at 8:02 a.m. by President, Dale McCabe.

Minutes:

Minutes of the May 2016 meeting were approved as submitted.

Treasurer's Report:

Balance is \$4817.60.

Damage Report:

There weren't any damages listed on Substructure Damage Summary, but Arthur did not receive monthly reports from all reporting organizations.

Old Business:

Discussed DIRT registry; Art will find out if there is a state damage chair and if every utility is required to be signed up with DIRT.

The OUCC Board Meeting discussed the amount of funding that goes to councils that aren't doing much outreach and have a high balance in their account. There is the possibility that the OUCC will require year end account balances to be reported.

New Business:

Danny gave examples of how other counties use their funds: booths at Beer/Wine Fests, car shows or as sponsors for events. This opened up the discussion about the new 811 trailer and if it will work for smaller events or if it's best used for large events. Future outreach was discussed: Hot August Nights, next year's Cherry Festival, farmer's market (plant giveaway and promotion of safe digging), sponsorship at fair and/or bidding on livestock (to be donated if winning bid), or sponsorship at the Tygh Valley rodeo.

Brewster will get information on the cost for sponsoring the 4th of July fireworks/concerts and the council approved the motion to spend up to \$500 for this sponsorship.

We'd like to continue to expand the 811 message to reach smaller contractors and the general public.
