MEETING MINUTES June 16, 2020 8:02 a.m. Zoom Conference



Figure 1 – Incoming Locate Ticket Requests by County






Figure 2 – Damages by Root Cause – Top 5 Damage Areas (determined by damages per 1,000 locate in bound locate ticket requests)




Figure 3 – Damages by Excavator Type and Work Performed




Figure 4 – Facility Damaged and Insufficient Locating Practices Breakdown
