## <u>New Business</u>

- President Weslee Cyphers reported the Council received information regarding sponsorship packages for the Wasco County Fair & Rodeo that will be taking place August 15 18, 2024, in Tygh Valley, OR. In 2023, the Council provided a sponsorship of \$250, providing a banner that was displayed at the event, at that time, that was the only sponsorship available. After discussion by the Council, a motion was made and seconded to approve a \$250 Arean Banner Sponsorship for the 2024 Wasco County Fair & Rodeo. Motion passed unanimously.
- Brian Logsdon, with One Call Concepts provided a presentation on the iSite Ticketing system that offers advanced Ticket Search capabilities, Locator Ticket Management and Positive Response, and ITICnxt, their latest version of the online ticketing system. Brian provided valuable information and insights at the benefits to the users and the efficiencies this new ticketing system provides. This presentation created good communication amongst the group.
- Scott Gallegos continued the discussion from the May 15, 2024, Council meeting regarding the merging of the Hood River UCC or the possibility of resuming their Council.
  - The suggestion was made to inquire about interest in Hood River County to see if there would be interest in either option of merging or resuming a Hood River UCC. Jesse Adams did inquire over the past month to various utilities and contractors, response was little to no interest.
  - Attendees suggested meeting on a bi-monthly basis vs. monthly basis.
  - Scott reminded attendees that they need to elect 3 officers to have a quorum.
     There were interested parties in attendance to fill these 3 positions.

- 2<sup>nd</sup> Street (2<sup>nd</sup> and Webber) Utility Project- new storm and sanitary sewer

   under way; completion middle of June
- Still working on 10<sup>th</sup> street; Safe Routes to School Projects finishing up design Construction to begin summer 2025; there will be some NWPUD poles that will need to be relocated, will also contact NW Natural regarding the gas lines in that area.
- Sidewalk and storm project for surveying and design Centurywest Company - Thompson/12<sup>th</sup> & Richmond – calling for locates – surveying has started - bidding next fall
- RBC installing big fiber line down by river Crates Way to Crates Way currently working off of west 2<sup>nd</sup> street (google side before they go over to River Road portion)
- Sewer line on East 9<sup>th</sup> & Thompson; new water line
- Design for upgrading sewer on 1<sup>st</sup> between Webber and cherry growers (quite a ways out) Locating on 1<sup>st</sup> Street & Webber with Public Works Dept for sewer project
- RBC 9<sup>th</sup> & Quinton Fiber relocation beginning June 18<sup>th</sup>
